FEDERAL TRADEMARKS LAW NO. 36 OF 2021

the Trademarks Law is the law that governs the use, registration, protection and cancellation of a Trademark (including a word, phrase, symbol, product shape, or logo to identify its goods and to distinguish those goods from those made or sold by another).

The Ministry of Economy is the institution governing and overseeing the registration and cancellation procedures of Trademarks in United Arab Emirates. Several authorities including but not limited to Federal and Local Courts, the Department of Economic Development, Criminal Investigation Departments and Customs Authorities are responsible for the enforcement of the Trademarks Law.

The Law also covers protection of Trademarks against Infringement, transferring ownership of the Trademarks and licensing the use of the Trademarks.

Other Laws governing Intellectual Property rights in UAE includes, Federal Law No. 38 of 2021 for Copyright & Neighbouring Rights, Federal Law No. 44 of 1992 for the Protection of Patents and Designs and Federal Law No. 17 of 2009 on the protection of new plant varieties.


